2019 Aug – present Program manager application landscape retender TenneTTSO B.V. (± 24 hours a week)

After years of single source TenneT switched to a best of breed sourcing strategy. This resulted in the parallel execution of several European tenders. Jean Pierre was asked to direct these tenders as a program. In the program he steers three multifunctional teams (procurement, legal, IT and business) totalling 20 professionals. Total contract value tendered approx. € 40 million, project budget € 1,5 million.

2013 Jun – 2020 Feb Managing partner Lucide B.V. (± 16 hours a week)

As founder and owner responsible for procurement and contract management agency Lucide B.V. This, with 12 own employees and approximately 7 external consultants services customers in local & central government, energy & water and business services. Providing knowledge, skills and capacity in the field of: IT procurement, contract management and service management.

2016 Oct – 2020 May Project manager & consultant IT-outsourcing Municipality of Groningen (± 24 hours a week)

At the municipality of Groningen, Jean-Pierre is responsible for the successful European tender and outsourcing of the entire IT. With his team of approximately 12 internal and external professionals, he devised the procurement strategy, drafted the complete bill of requirements (IT service management, workplace, telephony, network, hosting & housing, application management, technical integration, implementation, information security and hrm/staff) and executed the tender in accordance with its planning. Contract value € 72 million, contract duration 6 years. After the tender, Jean-Pierre supported the municipality in a capacity as trusted advisor for the executive management of the municipality and consultant in the field of: transition management, application management, contract management and service management.

2018 Sep – 2018 Dec Project manager market consultation new digital workplace TenneT TSO B.V. (16 hours a week)

Leading up to the European tender for a new digital workplace for the whole of TenneT, Jean-Pierre carried out a mark consultation as project manager. He led a small team of 6 subject matter experts.

2017 Sep – 2018 Mar Project manager implementation & certification ISO 27001 TenneT TSO GmbH (16 hours a week)

For TenneT Germany, Jean-Pierre led the project to obtain the ISO 27001 certification. With a team of approximately 12 TenneT employees from the Netherlands and Germany, the relevant business processes have been documented from the point of view of information security. Based on a risk analysis measures have been taken to mitigate critical findings that hinder successful certification. In March 2018, TenneT TSO GmbH successfully completed the ISO audit.

2014 Sep – 2017 Feb Interim manager architectuur landelijk netbeheerder TenneT TSO by (32 hours a week)

For TenneT, Jean-Pierre has merged the individual IT architects from the different departments and countries into one architecture department (26 fte). Processes, products and services are recalibrated and tailored to customer needs. Structural rationalization of the application landscape has been set up and implemented. Architecture governance is embedded and performance is measured and accounted for through KPI reports. In addition, Jean-Pierre was responsible for the preparation of the half-yearly presentations from the CIO office towards the Supervisory Board.

2013 Dec – 2014 Aug Project manager IT governance arvato Systems GmbH / Bertelsmann (24 hours a week)

Arvato Systems is the IT branch within the Bertelsmann group. Commissioned by the Bertelsmann CIO, Jean-Pierre coordinated the cooperation between four market units and the internal data center in such a way that the joint IT services are delivered standardized and coherently toward large customers. In this project Jean-Pierre directly led 8 project team members (4 project leaders, 3 service managers and 1 security officer) who in turn prepared 60 service managers and their organizations to work with and within the new governance.

2012 Oct – 2017 Mar Contract manager Futuro B.V. (shared service centre drinking water companies) (8 hours a week)

Futuro B.V was the partnership of five drinking water companies until the end of 2017. As a shared service center, the company provided ICT services to its shareholders (the drinking water companies). Jean-Pierre provided Futuro with contract management for the various outsourcing contracts with Cappemini, Accenture and SAP.

2012 Jun – 2014 Feb Consultant & project manager software development TenneT TSO B.V. (32 hours a week)

As a consultant and project manager attached to project Rapsodi. Rapsodi achieved the acquisition and implementation of a new Market Management System (MMS) through a European tender. This system, together with the Energy Management System (EMS), is at the heart of the TenneT system landscape. Jean-Pierre was responsible for the successful execution of the tender. After awarding, he moved on to the implementation project as business project leader. In this capacity, Jean-Pierre directed employees of TenneT as well as the two suppliers from France and the Czech Republic respectively. Responsible for: bill of requirements, assessment of offers, negotiations with suppliers, drafting contract documents.
